
Item 4 (c) Discussion on the implementation of the previous decisions of IGWG

Draft Conclusions and Recommendations

- 1. The Working Group reiterates its commitment to ensure that the language of its recommendations is consistent with the language enshrined in the provisions of the DDPA and the Outcome Document of the Durban Review Conference.
- 2. The Working Group invites the High Commissioner for Human Rights to reinforce the activities of the UN inter-agency task force in the domain of racial discrimination and related intolerance, at the working level, to enhance the implementation of the DDPA and the Outcome Document of the Durban Review Conference.
- 3. The Working Group agrees to allocate sufficient time in its upcoming sessions, within the existing timeframe and mandate, for Member States and other stakeholders, including regional organizations, to share their experience, including on good practices, implementation of ICERD, DDPA and the Outcome Document of the Durban Review Conference.
- 4. The Working Group agrees that at the beginning of each session it will review progress on implementation of recommendations adopted at the preceding session.
- 5. The Working Group commits to undertake further measures, with the assistance of OHCHR, to increase awareness on its recommendations and other relevant reports and studies by human rights mechanisms at the level of the Human Rights Council in order to enhance the effective implementation of the Working Group's recommendations and facilitate follow-up activities.
- 6. The Working Group commits to ensure that its recommendations are appropriately reflected in the resolutions of the Human Rights Council.
- 7. The Working Group acknowledges the achievements of OHCHR and calls on it to continue collecting information, including through the questionnaire circulated during the preparatory process for the Durban Review Conference, from all stakeholders on the implementation of the DDPA and make it available in due time to the Working Group. In this vein, the Working Group requests that the collected information is



placed on the website of OHCHR, which has to be duly and timely updated, and linked to the section on the outcome document of the Durban Review Conference.

- 8. The Working Group commits to adopt recommendations that are action-oriented and formulated in a clear manner, which will facilitate their consideration by the Human Rights Council.
- 9. The Working Group emphasizes the high importance of elaborating and adopting national action plans to combat racial discrimination and related intolerance, with the active participation of all stakeholders. To this end, it calls on Member States to provide information to the Secretariat on measures taken in this regard. It also calls on OHCHR to assist efforts of Member States to draft and revise national action plans. Moreover, the Working Group emphasizes the need for the relevant UN bodies and specialized agencies to provide, within their existing budgets, technical cooperation to enhance the effective implementation of ICERD, DDPA and the Outcome Document of the Durban Review Conference.
- 10. The Working Group invites the High Commissioner for Human Rights to continue ensuring the incorporation of the Durban Declaration and Programme of Action and the Outcome Document of the Durban Review Conference in the human rights mainstreaming in the whole UN system, and welcomes the leadership of the High Commissioner in this regard.
- 11. The Working Group invites relevant treaty monitoring bodies and special procedures mandate holders, in particular the Committee on the Elimination of Racial Discrimination (CERD) and the Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, to increase their participation in the sessions of the Working Group and to contribute actively to its deliberations.
