**PRE-TRIAL CHAMBER I** (the "Chamber") of the International Criminal Court (the "Court or "ICC") issues the present decision on the "Withdrawal as Counsel for the Government of the Union of the Comoros and as Legal Representative of Victims in Situation ICC-01/13"<sup>1</sup> (the "Request").

- 1. On 6 November 2014, the Prosecutor issued a report in which she decided that there is no reasonable basis to proceed with an investigation into the situation.<sup>2</sup>
- 2. On 29 January 2015, the Union of the Comoros, represented by Geoffrey Nice ("Mr. Nice") and Rodney Dixon ("Mr. Dixon"), submitted the "Application for Review pursuant to Article 53(3)(a) of the Prosecutor's Decision of 6 November 2014 not to initiate an investigation in the Situation"<sup>3</sup> asking that the Chamber request the Prosecutor to reconsider her decision.
- 3. On 24 April 2015, the Chamber issued the "Decision on the Victims' Participation",<sup>4</sup> in which, *inter alia*, it confirmed the victims' right to be represented by counsel of their choice, "provided they have been given a power of attorney".<sup>5</sup> As a result, Mr. Nice continued to represent some of the victims of the situation.
- 4. On 16 July 2015, the Chamber issued its decision on the request of the Union of the Comoros to review the Prosecutor's decision not to initiate an investigation, requesting the Prosecutor to reconsider her decision.<sup>6</sup> To date, the Prosecutor has not reconsidered that decision.
- 5. On 23 November 2016, the Chamber received the Request in which Mr. Nice, co-counsel for the Government of the Union of the Comoros and

legal representative of some of the victims, requests the Chamber's leave to

withdraw as counsel. He confirms that his withdrawal will "not otherwise

affect the composition of the legal teams" since his colleague, Mr. Rodney

Dixon, remains counsel for the two aforementioned participants, together

with "the rest of the legal team".7

6. The Chamber notes regulations 78 and 82 of the Regulations of the

Court (the "Regulations"). According to regulation 78 of the Regulations,

"[p]rior to withdrawal, defence counsel shall seek the leave of the Chamber".

Equally, regulation 82 of the Regulations makes clear that withdrawal of legal

representatives of victims requires prior "leave of the Chamber" Neither of

these provisions regulate the issue of withdrawal of counsel representing a

State, nor do the Court's statutory documents envisage such a situation.

Accordingly, the Chamber is of the view that the core principle applies

mutatis mutandis to counsel representing the State.

7. In view of the desire expressed by Mr. Nice to withdraw his

representation, and given that the Government of the Union of the Comoros

and the victims of the situation, hitherto represented by Mr. Nice, will not be

left without any legal representation, the Chamber grants the Request. The

Chamber reminds Mr. Nice that he remains subject to articles 8, 15 and 17 to

19 of the Code of Professional Conduct for counsel.

FOR THESE REASONS, THE CHAMBER HEREBY

**Grants** the Request.
