The Executive Board,

- 1. Recalling its decision 92 EX/3. 1. 1, Section III, paragraph 18, and its decision 93 EX/3.1, paragraphs 3 and 4,
- 2. <u>Recalling that the Special Committee has appointed an <u>ad hoc</u> working group of five members to continue the systematic and critical analysis of the functions of the Board in accordance with these decisions,</u>
- 3. <u>Having examined</u> with interest the report made by the Special Committee following its study of document 93 EX/SP/2 which the Working Group had prepared,

- 4. Is of the opinion that:
  - (i) there is no need to make a distinction, among the present functions of the Board, between functions which are considered to be essential and others considered to be less so; they all derive from present legal provisions and, accordingly, unless changes are made in those provisions, none of these functions can be abandoned;

- (ii) it is necessary to distinguish between the <u>function</u>, which is the responsibility of the Board and, as such, cannot be delegated, and the exercise of that function, preliminary or preparatory measures for which could be entrusted to subsidiary organs;
- (iii) it is important to continue with the critical and systematic analysis of the functions of the Board, with a view to seeing whether there is any need for these functions to be more appropriately divided between the General Conference, the Executive Board and the Secretariat, in accordance with the character and purposes of each of these organs, and, if so, suggesting what amendments should be made, where necessary, to the Constitution or to the other present legal provisions.

The Executive Board,

- 5. Taking account of the above considerations,
- 6. <u>Considers</u> that, in order to ensure the efficient exercise of its functions, it might adopt, as required, one or more of the following working methods:
  - the use of subsidiary committees or working groups, it being understood that such committees or working groups would not be permanent and should be set up only in cases where the complexity of the matters at issue justified a preliminary in-depth study;
  - (ii) the appointment of ad hoc special rapporteurs;
  - (iii) information-gathering field missions on Unesco's projects by one or more members of the Board at its specific request, for the purpose of enlarging the Board's capacity to appraise the execution of the programme;
  - (iv) the more general application of a procedure, analogous to the one used in studying document C/5, in order to facilitate the consideration of important and complex questions;
  - (v) to invite its Chairman to take decisions on its behalf in certain limited specific cases, and further to advise the Board in plenary on questions on the agenda which at first sight do not lend themselves to debate;
  - (vi) to continue, in collaboration with the Director-General, its efforts to reduce the volume of documentation and to improve the presentation of documents to be prepared for the Executive Board;
- 7. Decides further to pursue its search for more efficient working methods.

The Executive Board

- Notes that the Special Committee has invited its Working Group to continue the study of proposals concerning the structure of the Board and to determine the human and financial resources needed for the application of the various measures proposed;
- 9. <u>Also notes</u> that the Special Committee has decided to entrust to its Working Group the study of the possible establishment of a third Commission within the Board.

- 5. <u>Expresses its satisfaction with the present form of the Report and hopes that</u> greater attention may continue to be paid to the evaluation of activities;

- 2. <u>Decides</u> to submit the Draft Programme and Budget for 1975-1976 (18 C/5) to the General Conference at its eighteenth session, with the following observations and recommendations:

FIRST PART of Executive Board recommendations

#### Form and method of preparation of document 18 C/5

The Executive Board,

- 3. <u>Noting</u> that the preparation of the Draft Programme and Budget for 1975-1976 (18 C/5) was carried out in accordance with the directives laid down by the General Conference in 17 C/Resolutions 10.1, 34, 35 and 36, as well as by the Executive Board in its 93 EX/Decision 5.1,
- 2. Observing with satisfaction that document 18 C/5 has been well prepared,
- 3. <u>Realizing</u> the need for constantly improving the concentration and coherence of the programme,
- 4. <u>Believing</u> that 17 C/Resolution 38.1 setting forth guidelines for increasing the efficiency of the Secretariat should be taken into account by the General Conference when examining 18 C/5,
- 5. <u>Submits</u> its observations and recommendations to the General Conference under the following headings :
  - A. Consultations and other sources used for the preparation of 18 C/5
  - B. General considerations
  - C. Future of the United Nations system
  - D. The budget
  - E. Appropriation Resolution
  - F. The Secretariat
- A. Consultations and other sources used for the preparation of 18 C/5

The Executive Board,

- 1. <u>Observing</u> with satisfaction that, in general, proper account has been taken of the resolutions adopted by the General Conference at its seventeenth and earlier sessions,
- 2. <u>Noting</u> that only 22 Member States submitted proposals and suggestions concerning the Programme and Budget for 1975-1976 by the date stipulated and only 15 after the date stipulated, and that of all these, relatively few were developing countries,

- 3. <u>Noting</u> the Director-General's tribute to the quality, relevance and usefulness of the suggestions received, in spite of their divergencies,
- 4. <u>Calls the attention of Member States to the usefulness of their proposals and suggestions in the preparation of the Draft Programme and Budget;</u>
- 5. <u>Observing</u> that only 16 of the 35 international non-governmental organizations having consultative and associate relations with Unesco (Category A) presented comments or observations, within the framework of the consultations provided for under Article IV 4 (c) of the Directives,
- 6. <u>Reminds</u> organizations in Category A that the significance of the consultative status they have been given depends largely on the readiness of non-governmental organizations to respond when consulted by Unesco;
- 7. <u>Recognizes</u> that recommendations made to Unesco by various intergovernmental conferences and meetings have been taken into account to a large extent in the preparation of the Draft Programme;
- 8. Notes that the Secretariat has paid due attention to the suggestions made by delegations during the seventeenth session of the General Conference;
- 9. <u>Observes with satisfaction</u> that the Director-General, in the course of his critical examination of the execution of the current programme has assessed the results achieved, appraised the usefulness of projects, and gauged the Organization's capacity to carry them out, and that the drafting of 18 C/5 is the result of a collective effort of the Secretariat;
- 10. <u>Recommends</u> to the General Conference that it endorse the general observations presented <u>above</u>.
- B. General considerations

The Executive Board,

- 1. <u>Being aware</u> that there is a constantly growing demand for Unesco's services to its Member States,
- 2. <u>Agreeing</u> with the Director-General that, in the present circumstances, the basic principle of the programming of Unesco must be continuity, since most of the activities undertaken are of a long-term nature, but that innovations, including those incorporated in 18 C/5, are equally important for improving the impact of Unesco's work,
- 3. <u>Believing</u> also that it is timely to undertake a thorough and far-reaching review of the Organization's future development as well as new and bolder efforts in the fields of human rights, peace, and the struggle against colonialism, racism and all forms of discrimination,
- 4. <u>Considers</u> that even greater attention should be paid to the immediate needs of the developing countries and that, at the same time, an attempt should be made to ensure greater interest in Unesco's work and increased use of its services by the developed countries;
- 5. <u>Recognizes</u> the advantages of country programming, but is of the opinion that the United Nations Development Programme should provide increased support also to regional projects in such fields as educational research, book development and oceanography, among others, which require study and co-operation not only at the national but also at the regional levels;
- 6. <u>Acknowledges</u> the need further to strengthen Unesco's assistance to Member States in developing policies and structure a in Unesco's fields of competence to enable them the better to participate in and profit from the Organization's programmes;
- 7. <u>Considers</u> that special attention should be given by the Director-General and the Member States to the further development and strengthening of the rale of National Commissions;
- 8. Recommends to the General Conference that it endorse the above general considerations;
- 9. Notes the growth rate as proposed by the Director-General for Part II of the Programme and Budget.

- 4. <u>Recommends</u> further that in the light of its discussion, the General Conference take all appropriate steps to promote participation by Unesco, within the limits of its competence, in the common effort to put the United Nations system in a better position to contribute to the establishment of a new, more just, effective and fraternal world order.

- The Executive Board,

- 1. <u>Having examined</u> the Report of the Finance and Administrative Commission on its study of the financial and administrative aspects of the Draft Programme and Budget for 1975-1976 (94 EX/57, Part I),
- 2. <u>Noting</u> the discussions of the Finance and Administrative Commission with the Assistant Directors-General and Directors concerned with the several parts, chapters and sub-chapters of document 18 C/5,
- 3. <u>Is of the opinion</u> that the preparation of the Draft Programme and Budget for 1975-1976 (18 C/5) was carried out in accordance with the directives of the General Conference (37 C/Resolutions 34 and 35) and the guidelines of the Executive Board (93 EX/Decision 5.1);
- 4. <u>Recalling</u> its recommendations to the General Conference for additions to the Budget for 1975-1976 amounting to some \$815, 000, mainly to meet the cost of the introduction of Chinese as a working language of the General Conference and of Arabic as a working language of the Executive Board,
- 5. <u>Bearing in mind</u> the continued need to adhere as closely as possible to the guidelines for increasing the efficiency of the Secretariat as set out in a number of resolutions of the General Conference including 17 C/Resolution 38.1, and increasing the growth of the programme in relation to administrative expenditure,
- 6. <u>Bearing in mind</u> the continuing fluctuation of the value of the unit of account in relation to other currencies and in particular to the French franc as indicated in paragraph 12 of the Technical Explanation of 18 C/5 and in 94 EX/INF. 5,
- 7. Considering the serious effect on the budget of current inflationary trends,
- 8. <u>Decides in the light of the foregoing considerations to defer its final recommendation on the budget provisions until its 95th session;</u>

- 9. Decides further to establish a small working group to assist the Board in its consideration of these matters at its 95th session;

- 2. <u>Recognizing</u> the important role which extra-budgetary resources have in financing activities carried out by the Organization,
- 3. <u>Noting the relevant information provided in 18 C/5 on the extent and distribution of extra-</u> budgetary resources provided for by the United Nations Development Programme (UNDP),
- 4. <u>Being of the opinion</u> that similar information- should also be provided for all extra-budgetary resources, in particular for funds-in-trust,
- 5. Recognizing that estimates of such resources may of necessity only be tentative,
- 6. <u>Noting</u> that one of the major aims of programme budgeting is to budget by programme and not by objects of expenditure or administrative divisions,
- 7. <u>Recognizing</u> that it is important to know the actual costs of programmes when considering alternative courses of action,
- 8. <u>Being of the opinion</u> that wherever practicable, common service and administrative costs relating to a programme should be assigned to that programme,
- 9. <u>Requests</u> the Director-General to provide to the eighteenth session of the General Conference, information as to the amount and distribution of all extra-budgetary resources, as he has done in document 18 C/5 in respect of resources provided by UNDP;
- 10. <u>Recommends</u> to the General Conference that it invite the Director-General, when drawing up future programmes and budgets, to:
  - (a) provide information, wherever possible, as to the amount and distribution of all extrabudgetary resources; and
  - (b) to make every effort, wherever it is practical, to assign to a programme all costs necessary to carry out that programme.
- E. Appropriation Resolution

The Executive Board

Recommends to the General Conference that the following addendum to clause (e) of the Draft Appropriation Resolution proposed by the Director-General in 18 C/5 be added at the end of that clause:

#### F. The Secretariat

- 6. <u>Recognizes</u> that the training and retraining of members of the Secretariat is of great importance for the continued success of the Organization, and that the briefing courses for the newly employed field experts should be made more effective whenever possible;
- 7. <u>Considers</u> that direct contacts with Member States for purposes of recruitment should be improved in view of the increasing difficulties of finding highly qualified experts;
- 8. <u>Urges</u> Member States to assist the Director-General by presenting to him fully qualified candidates for director-level posts, with particular emphasis on fully qualified women candidates;
- 9. <u>Considers</u> that the development in activities financed from extra-budgetary resources in relation to those financed under the Regular Budget and the consequence of such development for the Secretariat should be kept under constant review in order to ensure that the Organization can continue to fulfil its overall constitutional tasks and retain its unity of action;
- 10. Commends to the attention of the General Conference the considerations set forth above.

The Executive Board,

Having examined Chapter 1 of Part II of the Draft Programme and Budget for 1975-1976 (18 C/5),

#### General considerations

- 1. <u>Approves</u> the programme's underlying principles as set out in the introduction to Chapter 1, and <u>reaffirms its conviction</u> that Unesco's activities in this field should continue to be characterized by the pursuit of the democratization and regeneration of education;
- 2. <u>Emphasizes</u> that the guiding principles for this democratization and regeneration must be sought in the concept of life-long education, <u>considers</u> that it would be advisable to continue to explore this concept in greater depth so as to be better able to clarify all its implications, recommends that increased efforts should be made to apply the essential aspects of life-long education in real situations and that the results of their application should subsequently be analysed;
- 3. <u>Considers</u> that the task of reflection and synthesis carried out by Member States and Unesco on the basis of the work of the International Commission on the Development of Education should be continued, and <u>hopes</u> that Unesco will assist Member States gradually to put into practice the main recommendations of the Commission in order to speed the process of adaptation of education systems to the actual circumstances obtaining in individual countries;
- 4. <u>Emphasizes</u> the need to devote adequate attention to the analysis and dissemination of the results of the most significant world educational experiments for the benefit of all Member States;
- 5. <u>Notes with satisfaction</u> that the reorganization and concentration of activities undertaken during the 1973-1974 biennium in the Education Sector make it possible to enter the 1975-1976 biennium in a spirit of continuity and consolidation of results already achieved whilst at the same time allowing the search for meaningful innovations and the efforts to improve still further the structure of the Education Sector to continue;
- 6. <u>Welcomes</u> the setting up of co-ordination machinery for the Regional Offices for Education, the International Bureau of Education, the Educational Institute for Educational Planning and the Hamburg Institute, and stresses the advisability of strengthening this co-ordination;
- 7. <u>Takes note</u> with satisfaction of the total of extra-budgetary resources available for promoting education at its different levels and in its different forms;
- 8. <u>Recommends</u> that everything should be done to ensure that Unesco plays an active and significant part, in the field of education, in International Women's Year (1975).

Sub-Chapter 1. 1 - Planning and financing of education

- 1. <u>Agrees</u> with the broad outlines of the proposed resolutions relating to this sub-chapter and recommends them to the favourable consideration of the General Conference;
- 2. <u>Considers</u> that special importance should be attached to the Conference of the 25 least developed countries, the educational aims of which will be more sure to be reached if all sectors of the Secretariat participate in the preparation of the Conference;
- 3. <u>Recommends</u> that the greatest attention should be given to activities for assisting Member States in the fields of educational policies, planning and administration, particularly by means of consultative services;
- 4. <u>Notes with satisfaction</u> the efforts made by the Secretariat to provide full information to <u>Member States about the various sources of international finance for assisting the develop-</u> ment of education, thus making it possible for governments to choose between the various forms of international co-operation;
- 5. <u>Welcomes</u> the activities proposed with respect to access to education of women and girls and certain specific groups (refugees, migrant workers and their families);
- 6. <u>Further recommends</u> that the Organization should, in the future, intensify its efforts to combat all inequalities of opportunity of access to education resulting from economic, social and cultural inequalities, and <u>stresses</u> the importance which the development of pre-school education for all children should have in such efforts.

III

Sub-Chapter 1.2 - Curricula, structures and methods of education

- 1. <u>Agrees</u> with the broad outlines of the proposed resolutions set forth in this sub-chapter and recommends them to the favourable consideration of the General Conference;
- 2. <u>Recommends</u> that efforts to develop the so-called intermediate or appropriate technologies should be continued, and that the programme on methods, materials and techniques should be conducted with a view to harnessing technological innovation to the general process of the renewal of education systems, in the perspectives opened up by life-long education;
- 3. <u>Welcomes</u> the results already achieved by the Asian Programme of Educational Innovation, which it would like to see developed further, and <u>expresses the hope</u> that the necessary studies will rapidly be undertaken with a view to launching programmes with similar objectives in the other regions;
- 4. <u>Approves</u> the setting up of a Division of the Structures and Content of Life-long Education whilst nevertheless reiterating that, in fact, the whole of the Secretariat must seek to put the concept of life-long education into practice;
- 5. <u>Welcomes with satisfaction</u> the programmes proposed for technical and vocational education and education for rural development, which are both of especial importance, and <u>hopes</u> that Unesco will increase its activities and the contribution it is making in these fields to the joint effort being undertaken within the United Nations system;
- 6. <u>Approves</u> the approach adopted to literacy activities, distinguished by a widening of the concept, by the concern to adopt methods of implementation appropriate to the variety of situations obtaining in different countries, and by intensified activity at post-literacy level;
- 7. <u>Recommends</u> that the activities in Section 1.26 (Special programmes) should be carried out in such a way as to ensure that each of the very varied programmes in this Section, most of which are, furthermore, interdisciplinary, retains its specific character;
- 8. <u>Recommends</u> strengthening and extending the programmes for the education of young people and adults with a view to helping them in their struggle against imperialism, colonialism, neo-colonialism and racialism, in all their forms and manifestations, and hegemonism;

9. <u>Further recommends</u> the continued strengthening and development of the specific programmes in education aimed at assisting young people and adults to participate in the struggle for human rights, fundamental freedoms and peace among nations, and against racial, religious and all other forms of discrimination, in a spirit of mutual understanding and desire for mutually advantageous co-operation between countries with differing social and political systems.

IV

Sub-Chapter 1.3 - Higher education and the training of educational personnel

- 1. <u>Agrees</u> with the broad outlines of the proposed resolutions relating to this sub-chapter and recommends them to the favourable consideration of the General Conference;
- 2. <u>Emphasizes</u> that this sub-chapter contains a greater volume of operational activities than any other sub-chapter in the Organization's programme, and <u>recalls</u> its previous observations concerning the advisability of leaving the initiative for these activities to national authorities and of making adequate provision for local staff to play a part in their implementation, and also concerning the need to provide as far as possible for on-the-spot training for staff who are nationals of the countries concerned;
- 3. <u>Recommends</u> that in the execution of this programme and in accordance with the requirements of life-long education, training for prospective educators should be so designed as to appeal not only to members of the educational profession but also to many other people who could play a part-time educational role, whilst teachers themselves might be enabled to undertake duties outside of school;
- 4. <u>Recalls</u> the importance and the multiplier effect which the training of educators has in the transmission and practical application of educational innovation;
- 5. <u>Reaffirms</u> the need to increase opportunities for the training of specialists in their own national environment;
- 6. <u>Notes</u> the value, as an additional recourse, of facilities made available abroad, the primary concern being the quality of the training programmes;
- 7. Reiterates that recourse to these facilities should not aggravate the problem of the brain  $\frac{1}{drain}$ .

V

#### <u>Sub-Chapter 1.4</u> - <u>Co-operation with international non-governmental organizations concerned</u> with education - Youth

- 1. <u>Agrees</u> with the broad outlines of proposed resolutions 1.41 and 1.42 and <u>recommends</u> them to the favourable consideration of the General Conference;
- 2. <u>Welcomes</u> the fact that the youth programme concentrates on priority topics (employment, the place of young people in cultural life, their commitment to peace and international understanding, etc. ) whilst at the same time developing its interdisciplinary character;
- 3. <u>Recommends</u> that the findings of the studies and consultations carried out under the youth programme should be given an adequate distribution among Member States;
- 4. <u>Recommends</u> that greater attention be paid to the strengthening of practical co-operation between Unesco and the international and national youth organizations which abide by the principles of Unesco's Constitution.

VI

Regional Offices for Education

1. <u>Considers</u> that the activities of the Regional Offices for Education are contributing to an effective decentralization of the Organization's work, thereby enriching its activities and improving its efficiency;

2. <u>Stresses</u> the advisability of further strengthening the Regional Offices for Education by increasing their human and material resources and assigning to them more responsibility and authority in operational, administrative and financial matters, with due regard for unity of conception and coherence of the implementation of the programme.

#### Chapter 1A - International Bureau of Education

- 1. <u>Recommends</u> that the General Conference give favourable consideration to proposed resolution 1. 51;
- 2. Notes with satisfaction the topic selected for the 1975 International Conference on Education.

#### B. NATURAL SCIENCES AND THEIR APPLICATION TO DEVELOPMENT

The Executive Board,

Having examined Chapter 2 of Part II of the Draft Programme and Budget for 1975-1976 (18 C/5),

Ι

#### General considerations

- 1. <u>Approves</u> the general orientation of the programme and, in particular, the four criteria followed in selecting the activities proposed in this chapter:
  - (a) to concentrate efforts in a few selected areas where international co-operation is most urgently needed both at present and in the years to come;
  - (b) not to do what others are doing, or can do, better for the benefit of mankind, and to offer material support and advice to increase the international scope of, and participation in such activities;
  - (c) to initiate and/or continue sponsoring programmes whose action will serve as catalyser for sustained national and/or international efforts;
  - (d) to undertake activities of global or regional importance for the execution of which a multidisciplinary organization is best placed;
- 2. <u>Is aware</u> that many of the serious world-wide problems, on which the general public and governments alike are today focusing their attention, call for convergence of natural and social behavioural sciences, and <u>recommends</u> that Unesco takes all appropriate measures to promote this trend for the benefit of all mankind;
- 3. <u>Approves</u> the basic reorientation of the chapter and welcomes its division into two subchapters :
  - 2. 1 Scientific and technological development;
  - 2.2 Environmental sciences and natural resources research;
- 4. <u>Commends</u> the undertaking of projects aimed at furthering the contribution of science to the development of society, bearing in mind that science policy forms part of the development policy of all countries, and commends the plans to increase public understanding of science;
- 5. <u>Commends</u> efforts towards further decentralization of the activities of the Organization and towards further strengthening of the Regional Offices of Science and Technology, by giving them clearly-defined terms of reference, increasing their operational means and assigning them more authority over their financial and administrative operations, but with due regard for unity of conception and coherence of implementation of the programme;
- 6. Notes the proliferation of science activities throughout the United Nations system and suggests that efforts be made to achieve a greater co-ordination and concentration so as to increase efficiency and reduce the total expenses of the United Nations system.

#### Sub-Chapter 2. 1 - Scientific and technological development

Section 2. 11 - Science in the 1970s: the human implications of scientific advance

- 1. <u>Recommends</u> that the General Conference give favourable consideration to the proposed resolution 2.11, changing the title of the Section to read: "Science in the Contemporary World: The Human Implications of Scientific Advance", and amending paragraph a (ii) of resolution 2. 11 to read "to study the means of reducing the gap between developing nations and those more advanced in the domain of science and technology";
- 2. Observes that this programme has gradually achieved a more advanced level;
- 3. <u>Commends</u> the proposal to create an advisory group to advise the Director-General on the interdisciplinary programme on the human implications of scientific advance;
- 4. <u>Draws particular attention</u> to the important "study of possible actions to narrow the science and technology gap" but finds that there is a discrepancy in the relation between the limited financial resources available and the great tasks envisaged.

#### Section 2. 12 - Science and technology policies

I - The development of national science and technology policies

- 1. <u>Recommends</u> that the General Conference give favourable consideration to the proposed resolution 2.121;
- 2. <u>Appreciates</u> the Organization's contribution to a global science and technology policy for the United Nations system and, in particular, the periodic revision of those sections of the World Plan of Action for the Application of Science and Technology to Development for which Unesco has a special responsibility;
- 3. <u>Commends</u> the proposal to convene in 1976 a Conference of Ministers of Arab Member States responsible for the application of science and technology to development (CASTARAB);
- 4. <u>Notes</u> that CASTARAB will complete the first cycle of such ministerial conferences which began in Latin America with CASTALA in 1965, and <u>believes</u> that now is the time to undertake the evaluation of the results of these conferences before another cycle is started;
- 5. <u>Notes with satisfaction</u> the responses to the science and technology policies programme to be carried on in 1975-1976, oriented, in particular, to the establishment of priorities for the national R&D systems and related scientific services;

II - International exchanges of world literature relating to science and technology policies

6. <u>Considers</u> that it is not yet able to recommend resolution 2. 122, pending further explanations and justification from the Director-General in respect of the method for undertaking a programme for the international exchange of information on literature relating to science and technology policies.

Section 2. 13 - Scientific and technological information and documentation

- 1. <u>Recommends</u> that the General Conference give favourable consideration to proposed resolution 2.13;
- 2. <u>Recognizes</u> the desirability of a better integrated distribution of responsibilities within the Organization, relating to documentation and information;
- 3. <u>Notes</u> the interim proposal of the Director-General to transfer to UNISIST all the projects financed from the Regular Budget or from extra-budgetary resources relating to scientific and technical documentation;
- 4. <u>Takes into account</u> resolution I adopted by the UNISIST Steering Committee during its first session and in particular Part C thereof;

- 5. <u>Recognizes</u> as does the Director-General, that serious consideration should be given to gathering together activities relating to documentation and information since they interact with the substance of the Organization's programmes;
- 6. <u>Attaches special importance</u> to the consultations which the Director-General proposes to undertake with a wide range of interested specialists, including users of information and documentation services, on the practical feasibility of the integration of functions and mechanisms contemplated, and the means of achieving it, and draws the attention of the General Conference to the detailed report which the Director-General is to present on this subject;
- 7. <u>Recommends</u> that the proposed integration should be achieved with prudence on the basis of the main objectives of the UNISIST programme to preserve its coherence and maintain its momentum.

#### Section 2.14 - Scientific research and higher education

- I The basic sciences
- 1. <u>Notes</u> the need for continuous collaboration between scientific research and higher education, and recommends that the General Conference give favourable consideration to proposed resolutions 2.141 and 2. 142;
- 2. <u>Observes with satisfaction</u> the well-established collaboration between the International <u>Council of Scientific Unions</u> and the Organization;
- 3. <u>Takes the view that Unesco's continued support to the International Centre for Theoretical</u> <u>Physics, Trieste, for the years 1975-1976, is acceptable but is of the opinion that Unesco's</u> relation with and subvention to the Centre should be re-examined carefully in the light of Unesco's total support to basic sciences;
- 4. <u>Notes</u> amongst the many important projects, for instance cell and molecular biology, applied microbiology, and in particular brain research and its relation to malnutrition;

II - University science education

5. Notes with interest the appropriate programme prepared for this important field.

#### Section 2.15 - Technological research and higher education

I - The applied and engineering sciences

- 1. <u>Notes</u> the growing importance of the close collaboration between technological research and higher education, and <u>recommends</u> that the General Conference give favourable consideration to proposed resolutions 2.151 and 2.152, amending paragraph (b) of resolution 2.151 to read "by assisting Member States, upon request, in the creation and development of engineering science research institutions, including computer centres, in the training of research and technical staff, and in the selected fields referred to in paragraph (a) above";
- 2. Commends in particular the training of researchers and technicians;
- 3. <u>Commends</u> Unesco's successfully initiated programme on the research and exchange of information on the use of solar energy and foresees the strengthening of this programme;

II - Engineering and technological education

- 4. <u>Pays great attention</u> to this programme which has its obvious value to the developing countries and an increasing significance also to many developed countries;
- 5. <u>Notes</u> the need of creating more working contacts between the "Man and the Biosphere" programme and environmental engineering.

#### III

#### Sub-Chapter 2.2 - Environmental sciences and natural resources research

- 1. <u>Notes with satisfaction</u> the timely introduction of the following sections into one unified subchapter and the fact that each sector of the environmental sciences has been divided into: (1) one part linked with Unesco's programme which is mainly concerned, on the one hand, with the general advancement of the sciences in question and, on the other hand, with assistance to developing countries; and (2) a programme for international co-operation focused on selected problems;
- 2. <u>Expresses the hope</u> that collaboration with the United Nations Environment Programme will increase rapidly to the desirable level.

Section 2.21 - The ecological sciences

- I The intergovernmental programme on Man and the Biosphere (MAB)
- 1. <u>Being aware</u> of the successful introduction of the intergovernmental programme on Man and the Biosphere, and the vitality of the programme on ecology and integrated land resources research, recommends that the General Conference give favourable consideration to proposed resolutions 2.211 and 2.212,
- 2. <u>Emphasizes</u> the great value of research into the long-term effect of human economic activities on the energy balance of the biosphere;
- 3. Agrees that due regard should be given to the difference in the magnitude of the ecological problems faced by industrialized and developing countries, which calls for establishing international guidelines;
- 4. Notes with satisfaction that the programme of MAB was rationalized and streamlined;
- 5. <u>Recognizes</u> the need for continuous and very close collaboration between the programme "Man and the Biosphere" on the one hand, and "Man in his Environment - Human Settlements" on the other hand;
  - II Ecology and integrated land resources research
- 6. <u>Appreciates that both the conservation of the biosphere and the rational use of natural resources are in the same section;</u>
- 7. <u>Referring</u> to the section on the water sciences, <u>urges</u> the Organization, in collaboration with the other Specialized Agencies concerned, to expand its studies and actions in order to find urgently needed solutions to the problems of Sahel regions and other arid areas.

Section 2. 22 - The earth sciences

- 1. <u>Being aware</u>, in particular, of the successful introduction of the International Geological Correlation Programme, <u>recommends</u> that the General Conference give favourable consideration to proposed resolutions 2.221 and 2.222;
  - I The International Geological Correlation Programme
- 2. <u>Considers</u> that there is an urgent need for international co-operation in scientific research relating to the exploration and evaluation of mineral and fuel resources;
- 3. <u>Takes into account that the International Geological Correlation Programme will be focused</u> on problems of Precambrian and Quaternary Geology, in view of their bearing on the genesis and distribution of ore deposits and on present-day development activities;
  - II The earth sciences and related natural hazards
- 4. Considers that the main goals of this programme are:
  - to promote international co-operation in research and data synthesis in the earth sciences;
  - to promote the study of natural hazards of geophysical origin;

5. <u>Attaches great importance</u> to the study of natural hazards (earthquakes, volcanoes, floods, landslides, etc.) creating terrifying disasters in various parts of the world, and to the development of methods to diminish their catastrophic effects.

Section 2.23 - The water sciences

- I The International Hydrological Decade
- 1. <u>Being</u> aware of the great success of the International Hydrological Decade which formally ends in 1974, <u>recommends</u> that the General Conference give favourable consideration to proposed resolution 2.231,
- 2. <u>Expresses</u> its appreciation of the success of this extensive programme carried out jointly by <u>Unesco</u>, FAO, WHO, WMO and IAEA;
  - II The International Hydrological Programme
- 3. <u>Recommends</u> that the General Conference give favourable consideration to proposed resolution 2.232, but that paragraph 9 of this resolution should be changed to read as follows:

"<u>Recommends</u> that they establish permanent national committees relevant to the programme, it being understood that wherever possible and where compatible with national practices, existing national committees for the International Hydrological Decade should be used as a basis for the formation of new committees and that these committees should contribute to the general co-ordination of hydrological activities at the national level relating to international programmes in hydrology";

- 4. <u>Being convinced that the International Hydrological Programme will be a logical successful</u> continuation of the International Hydrological Decade,
- 5. Agrees that the main fields of the International Hydrological Programme should be:

water balances and water resources assessment;

effect of man's activities on hydrological factors of the environment;

new developments in hydrology;

- III Water resources research and training
- 6. <u>Recognizes</u> that this sub-section represents an integral part of Unesco's continued efforts to develop research and training in the water sciences, and <u>recommends</u> that the General Conference give favourable consideration to proposed resolution 2.233;
- 7. <u>Draws attention</u> to the relations between water resources and human environment and <u>emphasizes</u> the necessity of enlisting the co-operation of technologists in the solution of the many environmental problems.

#### Section 2.24 - Marine sciences

- 1. <u>Conscious</u> of the growing importance of the marine sciences; <u>recommends</u> that the General <u>Conference</u> give favourable consideration to the proposed resolutions 2.241 and 2.242, which aim at hastening the development of Unesco's activity in this field;
- 2. <u>Considers</u>, while recognizing the merits of country programming, that the United Nations Development Programme should give increased support to regional projects concerning oceans and seas;
  - I General advancement of the marine sciences
- 3. Notes that the Division of Marine Sciences is in charge mainly of:

promotion of research programmes for advancement of the marine sciences; promotion of the study of marine coastal problems; promotion of information, education and training activities;

4. Observes that this Division is also concerned with the marine pollution of coastal waters;

#### II - Intergovernmental Oceanographic Commission

5. <u>Notes</u> that the Commission is in charge of the Long-Term and Expanded Programme of Oceanic Exploration and Research and its acceleration phase, i, e. the International Decade of Ocean Exploration.

# C. SOCIAL SCIENCES, HUMANITIES AND CULTURE

The Executive Board,

Having examined Chapter 3 of Part II of the Draft Programme and Budget for 1975-1976 (18 C/5),

#### Ι

#### General considerations

- 1. <u>Approves</u> the main trends and the renewal of the programmes of this sector, together with the accompanying clearer definition of objectives;
- 2. <u>Notes with satisfaction</u> the tendency gradually to give this sector a central position in the Organization's activities;
- 3. <u>Recognizes</u> that improvements have been made in the concentration and coherence of the programme since the seventeenth session of the General Conference;
- 4. <u>Regrets</u> that the extra-budgetary resources available to this sector remain very limited, thus preventing it from providing Member States with operational action services;
- 5. <u>Approves</u> the effort made to subsume a number of widely varying programmes under a single theme, namely the concept of "quality of life";
- 6. <u>Notes with particular satisfaction</u> the importance attached to culture and the recognition of its dominant role in arriving at an understanding of contemporary human problems, and recommends that the General Conference give special attention in its proceedings to the place of culture and to the definition of its role.

Π

Sub-Chapter 3. 1 - Philosophy and interdisciplinary co-operation

- 1. <u>Approves</u> the broad outlines of draft resolution 3.11 which it <u>recommends</u> to the General Conference for favourable consideration;
- 2. <u>Confirms</u> the central and fundamental role which philosophy is called upon to play in the conceptual evaluation of the Organization's programmes;
- 3. <u>Expresses its appreciation of the closer co-operation with all sectors which is evident in the philosophy programme;</u>
- 4. <u>Hopes</u> that greater scope will be allowed for philosophical reflection in all the programme sectors;
- 5. <u>Recommends</u> that the problems relating to human rights and peace continue to be given priority;
- 6. Stresses the importance of the experimental "Peace Forums";
- 7. <u>Agrees</u> with the interdisciplinary function of the Division and hopes that this function may more especially be exercised in close collaboration both with the humanities and with the social sciences in order to develop an interdisciplinary approach within these branches of study.

Sub-Chapter 3.2 - Social sciences

- 1. <u>Agrees</u> with the broad lines of draft resolutions 3.21, 3.22 and 3.23 which it <u>recommends</u> to the General Conference for favourable consideration;
- 2. <u>Welcomes</u> the progress made in giving the programme greater coherence and <u>expresses the</u> wish that efforts to this end may continue;
- 3. <u>Notes with satisfaction</u> the action taken with a view to developing a system of information concerning the social sciences and humanities, with due regard to the standards drawn up for UNISIST, and recommends that such action be continued;
- 4. <u>Declares its concurrence in the placing of special emphasis on the application of the social sciences to the questions arising in connexion with human rights and peace, development, population, the environment and drug abuse control, but <u>recalls</u> that the application of these sciences should be extended to all the programme sectors;</u>
- 5. <u>Considers</u> that the social sciences have a central role to play in the Organization's operational activities, particularly through the preparation of major international programmes with which specialists in the various disciplines would be associated, and to that end recommends that these sciences become even more effectively integrated into the work of other sectors;
- 6. <u>Further recommends that the reallocation of resources necessary to ensure the effectiveness</u> of this programme be made accordingly within the proposed budget.

IV

Sub-Chapter 3.3 - Cultural activities

- 1. <u>Approves</u> the broad outlines of proposed resolutions 3.31 and 3.32 which it <u>recommends</u> to the General Conference for favourable consideration;
- 2. <u>Welcomes</u> the importance accorded to cultural development and cultural policies and the increased attention shown to activities involving the arts, particularly artistic creation;
- 3. <u>Is of the opinion</u> that resources for this expanding programme should consequently be increased;
- 4. <u>Notes with satisfaction</u> the interdisciplinary trend of work in regard to cultural studies and the circulation of cultural works as well as the stress laid on inter-cultural exchanges.

V

Sub-Chapter 3.4 - Cultural heritage

- 1. <u>Approves</u> the broad outlines of proposed resolutions 3.41, 3.42 and 3.43 which it <u>recom-</u> <u>mends</u> to the General Conference for favourable consideration;
- 2. <u>Welcomes</u> the fact that the preservation and presentation of the cultural heritage is receiving better intellectual support whilst also being expanded at the operational level;
- 3. <u>Recommends</u> that, in the execution of its museum programme, particularly in its operational and training activities, the Organization should be guided by the most modern principles concerning the role of museums in the community, in line with a new, humanistic view of development;
- 4. Notes with satisfaction the attention given to the social and cultural repercussions of tourism;
- 5. <u>Also notes with satisfaction</u> the efforts made to take into consideration the qualitative aspects of human settlements (historic sites, cities and monuments) and to integrate them into a modern environment.

Sub-Chapter 3.5 - Man in his environment - human settlements

- 1. <u>Approves</u> the broad outlines of proposed resolution 3.51 which it <u>recommends</u> to the General Conference for favourable consideration;

The Executive Board,

Having examined Chapter 4 (Part II) of the Draft Programme and Budget for 1975-1976,

#### Ι

# General considerations

- 1. <u>Mindful</u> of the desire of the world community that information and communication media be used for the achievement of a just peace and mutual understanding between peoples; for the wider diffusion of knowledge, ideas and information, for advancing equality of opportunity, and for promoting a better sharing of cultures;
- 2. <u>Approves</u> the general orientation and objectives of the programme as outlined in the Introduction, and notes with satisfaction the unity of purpose underlying a diversified programme of action;
- 3. <u>Notes with satisfaction the increased importance given to research directed to facilitating</u> the elaboration of national communication policies;
- 4. <u>Approves</u> the principle of convening regional ministerial conferences to examine problems of communication policy;
- 5. <u>Endorses</u> the inclusion of programmes aimed at employing new techniques where appropriate and the potential of media for social communication to increase access to information and public participation in communication;
- 6. <u>Welcomes</u> the efforts aimed at a constant upgrading of training, professional performance and management skill and the advancement of institutional efficiency;
- 7. <u>Notes with satisfaction</u> the trend towards establishing regional advisory services designed to assist Member States in the achievement of these objectives;
- 8. <u>Reaffirms</u> the importance of associating competent professional organizations with Unesco's work in this field;
- 9. <u>Emphasizes the necessity of continuing to augment the effectiveness and the evaluation of projects.</u>

Sub-Chapter 4. 1 - Free flow of information and development of communication

- 1. <u>Agrees</u> with the broad outlines of proposed resolutions 4.11, 4.12, 4.13 and 4.14 and <u>recommends</u> that the General Conference give them favourable consideration;
- 2. <u>Stresses</u> the importance of promoting the two-way flow of information and <u>notes with satis-faction</u> the increasing importance attached to this matter in the Proposed Programme and Budget;
- 3. <u>Reaffirms</u> the importance of Unesco's work with regard to the free flow of information which includes the movement of persons and materials;
- 4. <u>Endorses</u> the emphasis laid on the responsibility of media managers and practitioners which is the essential accompaniment of the enjoyment of freedom of information;
- 5. Reaffirms the importance of the work carried out by Unesco with regard to:
  - (i) the problems arising in connexion with the content of information in Unesco's activities to secure the dissemination of information;
  - (ii) the principles of the responsibility as well as the rights of news agencies, in the light of the pertinent resolutions adopted by the General Conference;
- 6. <u>Expresses its concern at the growing world shortage of paper for printing, the increasing cost of books, and the effects these may have on the spread of education, science, culture and communication, and recommends that urgent attention be paid to this problem within the limits of Unesco's competence;</u>
- 7. <u>Reaffirms</u> the importance of the programme of research, policies and planning essential to the functional development of communication systems in Member States;
- 8. <u>Takes note with satisfaction</u> of the proposal to intensify Unesco's assistance to Member States in the planning and development of their communication systems;
- 9. <u>Approves the emphasis laid on the study and use of new technology designed to encourage</u> greater public access to and participation in communication;
- 10. <u>Welcomes</u> the proposals for the further development of the programme for book promotion and development, and <u>expresses</u> the hope that extra-budgetary resources will be forthcoming for the further strengthening of the regional book centres.

III

Sub-Chapter 4. 2 - Documentation, libraries and archives

- 1. <u>Agrees</u> with the broad outlines of proposed resolutions 4.21, 4.22, 4.23 and 4.24 and <u>recom-</u> mends that the General Conference give them favourable consideration;
- 2. <u>Recognizes</u> that the rapidly growing volume and sources of documentation and information call for the establishment of coherent national and local infrastructures for the collection, storage and retrieval of such information;
- 3. Welcomes therefore the emphasis placed in the programme on activities designed to assist Member States in the elaboration of systematic policies for the processing of documentation;
- 4. <u>Notes with satisfaction</u> that the programme is also directed towards the establishment of criteria for the international exchange of documentation and information, so as to allow universal access to the sum of world knowledge;
- 5. <u>Reaffirms</u> the importance of providing assistance to Member States in the development of their information and documentation services and in the training of qualified personnel for this purpose;
- 6. <u>Recommends</u> a reinforcement of the parts of the programme dealing with archives and with all types of libraries.

IV

#### Sub-Chapter 4.3 - Public information and promotion of international understanding

- 1. Agrees with the broad outlines of proposed resolutions 4.30, 4.31, 4.32, 4.33, 4.34 and 4.35 and recommends that the General Conference give them favourable consideration;
- 2. Welcomes the co-ordinated multi-media approach to the dissemination of public information and expresses the hope that further efforts will be undertaken to make Unesco's activities and the major problems with which it is concerned better known, using for this purpose as wide a range of sources as possible:
- 3. <u>Welcomes</u> the increasing number of Unesco Clubs and Associations and <u>recommends</u> that they be further encouraged and assisted;
- 4. <u>Notes with concern</u> the low rate of budget growth afforded to this section of the programme, which, at a time of rapidly increasing cost of supplies and services, may restrict the adequate distribution of public information materials.

# Sub-Chapter 4.4 - Statistics relating to education, science and technology, culture and communication

- 1. <u>Agrees</u> with the broad outlines of proposed resolutions 4.41 and 4.42 and <u>recommends</u> that the General Conference give them favourable consideration;
- 2. <u>Notes with approval</u> the emphasis laid on measures to improve the methodology and international standardization of statistical data, and on assistance to Member States for the development of their statistical services, notably by the appointment of regional advisers.

# E. INTER-SECTORAL PROGRAMMES ON HUMAN RIGHTS AND PEACE AND ON POPULATION

The Executive Board,

Having examined Chapter 5 of Part II of the Draft Programme and Budget for 1975-1976 (document 18 C/5),

# General considerations

- 1. <u>Notes with interest</u> the innovatory character of the presentation of the inter-sectoral programmes, which is fully in keeping with the aims and should be conducive to greater unity of conception while furthering the promotion and co-ordination of activities both within the Organization and outside it;
- 2. Approves the new structure and the main lines of emphasis of these programmes;
- 3. <u>Welcomes</u> the inclusion for the first time of genuine inter-sectoral programmes in the Draft Programme;
- 4. <u>Recommends</u> that the General Conference approve the programmes set out in this Chapter, <u>emphasizing</u>, however, the necessity of regarding the programme on human rights and peace as the most important of these inter-sectoral programmes.

#### Sub-Chapter 5.1 - Human rights and peace

- 1. <u>Takes note</u> of the broad outlines of proposed resolution 5.11 and <u>recommends</u> it to the favourable consideration of the General Conference;
- 2. <u>Confirms</u> the fundamental place that human rights and peace hold within Unesco's programmes and the consequent need for a division with responsibility for promoting and co-ordinating activities relating to these matters;

- 3. <u>Takes note</u> that the carrying out of the whole of this programme should continue to be very closely based on resolution 10. 1 adopted by the General Conference at its seventeenth session, and on any other pertinent resolutions;
- 4. <u>Takes note</u> that the advisory committee referred to in paragraph (f) of proposed resolution 5. 11 will be appointed as an Expert Committee (Article 56 of the Regulations for the general classification of meetings convened by Unesco);
- 5. <u>Recognizes</u> that the flexible, decentralized structure adopted should facilitate the achievement of the objectives of the programme while allowing for it to be adjusted to the sectoral frameworks and to the inter-agency co-operation which is particularly necessary in these activities;
- 6. <u>Considers</u> that the Organization should endeavour to associate itself to an even greater extent with the Decade for Action to Combat Racism and Racial Discrimination;
- 7. <u>Recommends</u> that the Organization make a substantial contribution to activities undertaken on the occasion of International Women's Year in its fields of competence and give the widest publicity to its efforts and to the results achieved;
- 8. <u>Stresses</u> that research concerning peace and disarmament should have due regard both to <u>Unesco's</u> field of competence and to work already being done by other international organizations;
- 9. <u>Recommends</u> that the necessary preparatory steps be taken with a view to launching other studies on topics of major importance;
- 10. Further recommends that efforts be made to strengthen activities in this field which could have an impact on the international public at large and especially on youth.

Sub-Chapter 5.2 - Population

- 1. <u>Takes note</u> of the broad outlines of proposed resolution 5.21 and <u>recommends</u> it to the favourable consideration of the General Conference;
- 2. <u>Conscious</u> of the importance of population variables for the overall process of socioeconomic development and ultimately for the quality of life,
- 3. <u>Aware</u> of the importance in this respect of activities, in co-operation with Member States, in the fields of education, culture, the social and natural sciences and communication, related to population questions,
- 4. <u>Welcomes</u> the development of the Organization's inter-sectoral programme in the field of population;
- 5. <u>Notes with particular satisfaction</u> the stress laid on respect for human rights, cultural values and national sovereignty as the basic principles underlying the Organization's action in this field;
- 6. <u>Expresses</u> satisfaction both with the increase in Regular Budget provisions and with the resources made available for the programme by the United Nations Fund for Population Activities.

# Multinational corporations

- 1. <u>Recalling</u> resolution 10. 1, paragraph 20, adopted by the General Conference at its seventeenth session with regard to Unesco's contribution to United Nations action concerning study of the practices of multinational corporations, particularly in the developing countries, in the fields of competence of the Organization,
- 2. <u>Recalling that United Nations action in this field was defined by resolution 1721 (LIII) unani-</u> mously adopted by the Economic and Social Council on 28 July 1972,

- 3. <u>Noting</u> that the United Nations General Assembly has adopted a "Declaration on the Establishment of a new International Economic Order" and a "Programme of Action" at its sixth special session,
- 4. <u>Noting</u> that the "Report of the group of eminent persons to study the impact of multinational corporations on development and international relations" is already available,
- 5. <u>Convinced</u> of the necessity of Unesco's contribution to a study of this question in its fields of competence,
- 6. Recommends that the General Conference should:
  - (i) include in the Programme for 1975-1976, a provision to convene a group of experts in 1975 in order to:
    - (a) assess the conclusions of the above-mentioned Report in so far as they bear on matters within Unesco's competence;
    - (b) report on the impact of multinational corporations in the fields of education, science, culture, communications, environment and development;
    - (c) propose such further studies as may be necessary to permit adequate understanding of these questions;
  - (ii) invite the Director-General to:
    - (a) place the experts' report and recommendations before the nineteenth session of the General Conference, with proposals for further action to be included in the Draft Programme for 1977-1978;
    - (b) co-operate as appropriate with United Nations agencies in any other action to follow-up the ECOSOC Report;
  - (iii) allocate the necessary funds for these purposes within the appropriations it will approve for 1975-1976.
    - F. INTERNATIONAL STANDARDS, RELATIONS AND PROGRAMMES

The Executive Board,

Having examined Chapter 6 of Part II of the Draft Programme and Budget for 1975-1976,

#### Sub-Chapter 6.1 - International standards and copyright

1. <u>Agrees</u> with the broad outlines of proposed resolutions 6.10, 6.11, 6.121, 6.122 and 6.123 and recommends them to the favourable consideration of the General Conference;

- 2. <u>Approves</u> the lines of emphasis of the programme relating to international standards, which reflect the proposals for standard-setting activities appearing in other chapters of the Draft Programme and in the second part of Sub-Chapter 6.1;
- 3. Expresses concern at the growth of these activities, already noted in previous programmes;
- 4. <u>Notes</u>, however, that the standard-setting activities proposed in document 18 C/5 are based in certain cases on decisions already taken by the competent bodies and must, in any case, be spread out over more than one biennium;
- 5. <u>Recommends</u> that the General Conference consider the problems to which this growth in standard-setting activities may give rise, and the possible desirability of providing for a certain order of priority and a more gradual phasing of such activities, having due regard, <u>inter alia</u>, to the contribution that international non-governmental organizations can make to them:

- 1. <u>Agrees</u> with the broad outlines of proposed resolution 6.31 and recommends it to the favourable consideration of the General Conference;
- 2. <u>Stresses</u> the importance of the Participation Programme for the greater flexibility it introduces into the action of the Organization and for its stimulating effect on activities in Member States.

# IV

#### Sub-Chapter 6.4 - International programmes

- 1. <u>Agrees</u> with the broad outlines of proposed resolutions 6.41, 6.42, 6.43, 6.44, 6.45 and 6.46 (18 C/5) and recommends them to the favourable consideration of the General Conference, with the following addition under paragraph 5 of proposed resolution 6.41:
  - (d) to continue to report periodically to the Executive Board by providing it with information on problems and difficulties encountered in Unesco's participation in the country programming exercises an% on development co-operation projects financed by the United Nations Development Programme;
  - (e) to continue to report also on other matters arising from the Organization's overall relations with the United Nations Development Programme as well as on measures taken by the Director-General in accordance with relevant resolutions of the United Nations organs;
- 2. <u>Reiterates</u> its conviction that the co-operation between Unesco and the international programmes referred to in Sub-Chapter 6.4 is of the utmost importance in the process of making Unesco's action increasingly fruitful for its Member States.

# Sub-Chapter 6.5 - Funds-in-trust

- 1. <u>Agrees</u> with the broad outlines of proposed resolution 6.51 (18 C/5) and <u>recommends</u> it to the favourable consideration of the General Conference;
- 2. <u>Stresses</u> the importance of the activities carried out through increasing funds-in-trust;
- 3. <u>Recommends</u> that the General Conference, at its eighteenth session, pay particular attention to projects for which the Organization is acting as executing agent under fund-in-trust

arrangements and examine whether there are grounds for redefining the status and guiding principles of projects of this type, together with their place in the programmes".

- 4. Decides that among the topics to be studied in depth in 1975- 1976 on the basis of the Director-General's Report on the Activities of the Organization should be "publications policy and implementation".

- 2. <u>Having examined</u> document 18 C/4: "Analysis of problems and table of objectives to be used as a basis for medium-term planning (1977-1982)",
- 3. <u>Expresses its appreciation</u> to the Director-General for the comprehensive conceptual analysis of problem areas, problems and long-term objectives necessary for the preparation of a medium-term plan;
- 4. <u>Draws the attention</u> of the General Conference in particular to the quality of the analyses which introduce, support and clarify each of the proposed objectives and, lying beyond them, all the ultimate aims which it is Unesco's purpose to serve;
- 5. <u>Recommends</u> that the General Conference give favourable consideration to those problem areas, problems and objectives as a sound basis for the preparation of a medium-term plan.

- 1. <u>Recalling</u> resolution 1. 323 adopted by the General Conference at its seventeenth session, authorizing the Director-General, in the event that the United Nations General Assembly should decide to establish a United Nations University, to take, in close co-operation with the Secretary-General of the United Nations, the necessary measures for participating in the establishment of the University,
- 2. <u>Recalling</u> its own discussions and decisions on the United Nations University, and in particular 93 EX/Decision 4.3.2, in which it reaffirmed its desire that Unesco should share in the establishment and subsequent operation of the University, and in which it made comments on and proposed amendments to the draft charter prepared by the Founding Committee,
- 3. <u>Notes with satisfaction</u> that the General Assembly of the United Nations adopted in its resolution 3081 (XXVIII) the Charter of the United Nations University, taking into account the decision, comments and observations of the Executive Board of Unesco on the draft prepared by the Founding Committee;
- 4. <u>Welcomes</u> the decision of the General Assembly that the University Centre of the United Nations University shall be located in the Tokyo metropolitan area in Japan;
- 5. <u>Invites</u> the Director-General to participate actively in the launching of the University and ensure close co-operation between the activities of Unesco and those of the University, particularly in view of the present and projected programme and activities of Unesco relating to pressing global problems of human survival, development and welfare necessitating high-level research and training;
- 6. Decides to include in the Provisional Agenda of the eighteenth session of the General Conference an item entitled "The United Nations University", and invites the Director-General to submit a report summarizing the action which has led to the establishment of the United Nations University and containing proposals regarding measures to be taken to enable Unesco to play its proper role in the development of the University, and to ensure effective and constructive co-ordination between Unesco and the United Nations University for their mutual benefit.

The Executive Board,

1. <u>Having considered</u> the Director-General's report on recent decisions of the organizations of the United Nations system of interest to Unesco (94 EX/26 and Add, ),

- 2. <u>Believing</u> that these decisions represent an important source for the preparation of Unesco's programmes,
- 3. <u>Further believing that the improvement of co-operation between organizations</u> of the United Nations system remains a priority goal,
- 4. <u>Recalls</u> the usefulness for its future work of keeping this item on its agenda and of the reports submitted on this subject;
- 5. <u>Takes note</u> of the report mentioned in paragraph 1 and the additional information on this subject supplied by the Secretariat.

III

The Executive Board,

- 1. <u>Recalling</u> that various problems alluded to in the above report have been discussed and have been the subject of decisions, on the one hand, when Part II of document 18 C/5 was considered in detail and, on the other hand, on the occasion of the discussions relating to various items on the agenda of its present session, viz. items 7. 2, 7. 3, 7.4. 1, 9. 2 and 9.4,
- 2. <u>Further recalling in the same connexion that it is adopting a separate deci-</u> sion (7. 1. I) on the United Nations University,
- 3. <u>Calls the attention of the Director-General to the observations and sugges-</u> tions recorded in the report of the Programme and External Relations Commission, and <u>invites him to take them into account (a)</u> in the preparation of future programmes; and (b) in continuing his co-operation with the United Nations and the other organizations of the United Nations system.

- 2. <u>Mindful</u> that the Arabic language is the national language of 20 Member States in an area of the world distinguished by the originality of its thought and culture, with more than 130 million people, and one of the cultural languages of many people in Asia and Africa,
- 3. <u>Recalling</u> resolution 17 of the fourteenth session of the General Conference which invited the Director-General to study the measures necessary to give Arabic progressively the same status as the four other languages defined as working languages by the Rules of Procedure of the General Conference and decisions of the Executive Board,
- 4. <u>Further recalling</u> that the General Conference considered, in resolution 8.4 adopted at its eleventh session, that Unesco documents will have the most effective impact on Arab and Arabic-speaking countries if they are circulated in the Arabic language,
- 5. <u>Considering</u> that resolution 47 of the sixteenth session of the General Conference invited the Director-General to ensure the introduction of the second stage of the use of Arabic as a working language at the eighteenth session of the General Conference,
- 6. <u>Recommends</u> that the General Conference, at its eighteenth session, adopt Arabic as a working language of the Executive Board with the same status as the other working languages of the Executive Board;
- 7. <u>Recommends</u> consequently that the General Conference increase the proposed appropriations in Part I, Chapter 2 of the Budget by \$549, 000 for this purpose;

8. <u>Invites</u> the Director-General, pending the decision of the General Conference, to take the necessary measures to ensure simultaneous interpretation from and into Arabic at the 95th and 96th sessions of the Executive Board.

- 2. <u>Recalling likewise</u> that, at the same Special Session, the General Assembly declared that the Charter of the Economic Rights and Duties of States "shall constitute an effective instrument towards the establishment of a new system of international economic relations based on equity, sovereign equality, and interdependence of the interests of developed and developing countries",
- 3. <u>Considering that the full achievement of Unesco's purposes depends in a large</u> measure on the establishment of such a new international economic order, based on equity, justice, the eradication of poverty and the fair distribution of the resources of the world,
- 4. <u>Commends</u> the efforts currently under way by a Working Group drafting the <u>Charter of</u> the Economic Rights and Duties of States, and <u>reiterates</u> that "it is of vital importance that the Charter be adopted by the <u>General Assembly</u> at its next session";
- 5. Draws particular attention to the potential role of Unesco, in the context of the powers and tasks assigned it by the Constitution, in giving full effect to the programmes envisaged in the said Charter, and recommends that pending the completion of this Charter, and it being agreed upon in time for consideration by the eighteenth session of the General Conference of Unesco, this item be inscribed on the Provisional Agenda of the said Conference in connexion with the Organization's formulation of its programme for the next biennium.
